Innovative Prosecution Solutions: Project Overview	
<u>Purpose</u>	Support state and local prosecutors seeking to reduce crime through legal initiatives that offer alternative criminal justice avenues for the offender, and/or specific services for the victim
<u>Targeted Populations</u>	<ul style="list-style-type: none"> • High gun-related crime offenders at risk recidivism • Repeat domestic violence offenders • 18-25 year old non-violent felony offenders who are at risk of recidivism • Dual human trafficking victims and criminal defendants; human traffickers • 12-24 year old juvenile and young adult offenders who are low-level misdemeanants at risk of recidivism • Victims of violent crimes • Offenders and victims within high-crime areas • 16-24 year old juvenile and young adult offenders • Gang-affiliated violent offenders • Communities with high levels of gun-related violence • Reducing opioid-related overdose incidents • Reducing violent crime associated with the trafficking of illicit opioids
